President's Report by R. Peterson The congregation name is now officially Borderlands Unitarian Universalist Congregation so that change needs to be made know to the appropriate groups. The Endowment Committee has not met with the Finance Committee this month. A presentation by Building and Grounds will be on the June agenda.

Minister's Report by Rev, Wispelwey. He has been with the congregation for four months that was intensely busy with pastoral work. A week for recouperation was appreciated. Collaboration with President Peterson has been ongoing.

Minutes of the distributed April Board meeting were approved.

Treasurer's Report was approved. The printout is on the last page of the minutes. There will be a change in service agreement for use of the copier. ESL group's money has been held for them and will be returned now that the program is being renewed.

Old Business

Website Progress Barbara Lund said that the final report of the committee has been written but the work will continue. It has been months of effort. She introduced Maureen Kirk, the producing administrator and editor to give a traffic report.

She said that decisions that were made for abbreviating words and font changes to fit space. The website is 26 pages long and includes three videos, seven forms for gathering information, photos, art, addresses and more. The traffic report had

data such as devices used by the website searchers, numbers and minutes used, and more. Most searchers used the computer and were In Green Valley. The editors were positive about the responses and use to date.

Pledge Report by D. Mitchell and K. Creten. The goal of the Pledge Drive was \$124,645. To date the pledges amount to \$121,125. The committee welcomes additional pledges. The committee thanks the members for their generosity.

Contract for Facilities Rental by R. Peterson. A <u>Faculties Use Agreement</u> was distributed to the board. The form included information about the renter and included cost and time for of each space to rent. It was suggested that "to be negotiated" be added to the line about equipment fees. <u>A Facilities Use Check</u> — <u>Out List</u> was also sent to the board before the meeting. The board approved both of these forms which had been developed by the committee.

Handicapped Parking Update Borderlands UU parking area has three handicapped spaces. The hope is to add at least eight more "limited mobility" spaces. At a previous board meeting a \$30,00 bid for concrete extension of parking adjacent to the west side of the veranda was quoted with no further details.

A bid from Seal Right for \$9729.00 including tax was presented. The company listed the asphalt and other materials to be used. Details for preparing the site, applying the asphalt and finishing were explained. Aerial photos of the site were sent with the estimate. The company has a website with references. The B & G committee has attempted to get other bids. No source of funding was designated. No vote was taken.

Signage for Restrooms Only the restroom in the gallery has space for a wheel chair to turn but maybe not fit the legal specifications. The male/female signs are against the UU principles for signs. The commode height is common for handicapped areas. The outdoor restrooms were not inspected.

Spiritual Nourishment/Worship Arts Chair Diane Farone send to the board a Fiscal Year 2023 report listing accomplishments of the committee starting July 3. Rev. Seth was discovered. Leslie Carter was recruited to re-establish the choir. Sixteen Sunday services were led by our members and friends. Nine services were led by guests. Rev. Seth presented thirteen services since January. A celebration of life ceremony was held for Sonia Collins. (The report included more than two pages of services topics with speakers from July 3 to May 3.)

Summer and Fall services were structured with significant audience reflection and participation from which we received good ideas about what the members and friends would like to see more of. List generated by the discussion of the six sources lead to ideas for presentations especially about more about world religions. Our recent discussions will give concentration for our future to encourage reflections on why we come to church, who we want to become and how we can structure ourselves to accomplish what that is.

Current members of the Worship Arts Team are Diane Farone, chair: Nancy Murphy, in charge of service associates, Mary Arrigoni, Martha House, Ginny Lopez, Marilyn Taylor and Rev. Seth. Leslie Carter is a member when the choir is in session. Lorelei Schober was a member of the team that planned the summer services.

Additional important people for the Sunday activities are: Deborah Gregory is the leader of the group that collects the offering and Ann Westrope is in charge of the people who count the money collected on Sundays. Jermain prints the Order of Service and Larry Parker is the lead person on the sound and projection system. Barbara Meshanko and Jim Lund are the main kitchen wizards. Jim Lund plans the forum presentations before church. Ginny Lopez organized the book group that meets Sunday after church as well as poetry reading gatherings.
